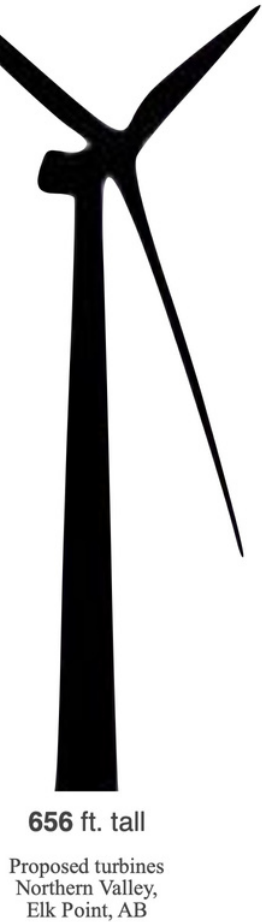
The Cost to Livestock & Wildlife
